Compression Ignition Engines used in Agricultural Operations Form Instructions

- 1. Registration to be Issued To (Company Name) Legal name of entity, business, organization, agency, or private individual that operates equipment.
- 2. Company Mailing Address Address where all business correspondence is to be mailed.
- 3. *Company Street Address* If left blank, we will assume street address is the same as mailing address. Street address cannot be a P.O. Box.
- 4. *Company Information* The email, phone, and fax numbers need to belong to the company, not a third party. Examples of third party members are consultants, distributors, sales representatives, lawyers, etc.
- 5. General Nature of Business Please state the type of agricultural operation applying for registration.
- 6. Total Fees Each application for a Certificate of Registration must be accompanied by the supporting information form for the particular source category AND the fees required for the application and registration of each unit. For new engines, the fees are structured so that the fees include an application fee of \$75.00 and a 2-year registration fee of \$101.73 for a total of \$176.73. New engines are those engines installed less than 90 days before the time of registration. Existing engines are engines installed and not registered at the time of installation (such as those applying for an initial registration during an amnesty period) and subject to back registration and missed renewal fees from the time of installation. Please confer with District staff to obtain the correct fee for existing engines. Include a check payable to Butte County Air Quality Management District.
- 7. *Transfer of Ownership* Form 1 may be used to transfer the registration of equipment from one owner to another. A Transfer of Ownership is only valid for engines included as part of the sale of a farm; the engine cannot be relocated unless the engine meets the Tier 3 standards. Include the former owner information and registration number. Calculate the Transfer of Ownership fee.
- 8. *Printed Name of Owner/Operator* the individual employed or otherwise retained by a company, public agency, or municipality, or his contracted designee, who has the authority to certify that the engine used in ag operations complies with all applicable requirements of the District Rules and Regulations. This person must be a direct employee to the company, not a third party. Examples of third party members are consultants, distributors, sales representatives, lawyers, etc.
- 9. Signature of Owner/Operator with Date Signature of person described above. (Application will not be accepted unless signed and dated.)
